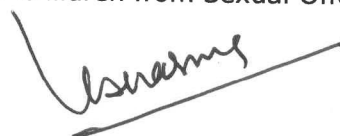

AFFIDAVIT

1. I, Dr. V. K. Sharma, S/o Late Mr. Roop Chand Sharma, aged about 65 years, resident of F-83, Sector-44, Noida, Uttar Pradesh, in my capacity as the Chairman and Authorised Signatory of Aster School, do hereby solemnly affirm and declare as under:
2. That Aster School is being run and managed by Shiva Educational and Welfare Society, having its registered office at A-1, Sunder Garden, Mayur Vihar Phase-1, New Delhi.
3. That Aster School is situated at Plot No. 1A/5, Knowledge Park-1, Greater Noida, Uttar Pradesh, and is being established and operated for the purpose of providing quality education to students in accordance with the applicable laws, rules and regulations.
4. That the School is being run as a non-profit educational institution under the management of Shiva Educational and Welfare Society and its activities are in accordance with the objectives contained in the Memorandum of Association/Bye-Laws of the Society.
5. That the School shall comply with all applicable provisions, norms, rules, regulations, bye-laws, circulars and instructions prescribed by the Central Board of Secondary Education (CBSE) and other competent authorities from time to time.
6. That the School possesses/proposes to maintain adequate infrastructure and facilities as required under the applicable CBSE norms, including classrooms, laboratories, library, computer facilities, sports facilities, sanitation facilities, safe drinking water, safety and security arrangements and other necessary facilities.

8. That the School shall follow the curriculum, academic standards, examination system and other academic requirements prescribed by CBSE after grant of affiliation.
9. That the School shall maintain proper records relating to students, staff, attendance, fees, accounts, infrastructure, academic activities and other statutory requirements and shall produce the same before CBSE or any competent authority whenever required.
10. That the School shall charge fees in accordance with the applicable rules and regulations and shall not collect any capitation fee, donation or any other amount in contravention of the applicable provisions.
11. That the income and funds of the School shall be utilised solely for the advancement of the educational objectives of the institution and no part thereof shall be distributed as profit, dividend or otherwise to the members of the Society, office bearers or any other person.
12. That the School shall provide and maintain adequate arrangements for safe drinking water, sanitation, hygiene, cleanliness and health for students and staff.
13. That the School shall comply with all applicable requirements relating to fire safety, building safety, electrical safety, disaster management, transportation safety, child safety and security, as prescribed by the competent authorities.
14. That the School shall comply with all applicable laws and regulations relating to the protection and safety of children, including the provisions of the Protection of Children from Sexual Offences Act, 2012 (POCSO Act) and other applicable laws.



15. That the School shall take appropriate measures to prevent corporal punishment, child abuse, harassment, discrimination and any other practice detrimental to the safety, dignity and welfare of students.
16. That the School shall provide a safe, inclusive and conducive educational environment to all students without discrimination on any prohibited ground.
17. That the School shall comply with the applicable provisions of the Right of Children to Free and Compulsory Education Act, 2009, and other applicable educational laws and regulations.
18. That the School shall constitute and maintain such committees and mechanisms as may be required under applicable laws, CBSE regulations and directions of competent authorities, including mechanisms relating to child protection, grievance redressal and prevention of sexual harassment.
19. That the School premises shall be used primarily for educational purposes and shall not be used for any activity contrary to its educational objectives or in violation of applicable laws.
20. That the School shall maintain all necessary statutory approvals, certificates, permissions and documents required for running the School and shall submit the same to CBSE or any other competent authority whenever required.
